Dear Friend,

Furious. Afraid. Concerned.

These words encompass the emotional turmoil that many of us have been experiencing since the U.S. Supreme Court placed control of our bodies in the hands of state lawmakers.

Today, more than one in three women of reproductive age across the country, plus many transgender and nonbinary people, live in states without access to abortion — endangering the lives of millions.

The laws that those politicians have passed — which the Supreme Court greenlighted — have forced people into dire positions. Some have made the costly decision to travel hundreds, or even thousands, of miles across state lines to get the health care they urgently need. Others have resorted to self-managing their abortion outside of the medical system. Many have no choice but to remain pregnant against their will because they fear criminalization or lack the funds to travel out of state.

Planned Parenthood has been working aggressively to meet the needs of patients everywhere — especially those facing disproportionate barriers to health care access due to racial injustice and economic inequality. With more states pushing hostile abortion bans and restrictions, more people are counting on us to address the critical, growing need for care and support.

And we're counting on people like you — people who care about reproductive freedom and the future of our fundamental rights — to help meet this historic challenge.

Take Charlie, a mother of two who lives in San Antonio, Texas, where abortion is banned. Charlie's closest option for care is more than 600 miles away in Las Cruces, New Mexico. The cost for her to access an abortion — including travel, lodging, food, child care, wage losses, and medical care — totals over \$1,700.

The financial and emotional toll of traveling out of state to get a legal abortion is different for every patient. However, Charlie's story, like countless others, demonstrates how anti-abortion laws have created a cruel and inhumane reality.

Planned Parenthood affiliate staff and providers are doing everything in their power to make sexual and reproductive health care accessible to all. We're doing that by:

- supporting patients directly to help pay for travel, overnight stays, and other related expenses, including the cost of an abortion;
- deploying patient navigators to help people who need abortions find providers, schedule timely
 appointments, and make travel arrangements as well as assist them with other logistical issues such
 as child or elder care;
- advocating for legal or constitutional protections to build and expand the network of safe states where access to abortion is protected;
- recruiting providers to build capacity at Planned Parenthood health centers in abortion access states
 — which have become regional hubs for patients traveling from states with abortion bans or severe restrictions; and
- expanding the use of telehealth to improve access to birth control and abortion where allowed, and to make that access more equitable.

Planned Parenthood is doing this work to build a better future — one that goes beyond the protections of *Roe v. Wade* and guarantees that anyone can access sexual and reproductive health care, no matter who they are, where they live, or how much money they have.

Planned Parenthood affiliates — supported by Planned Parenthood Federation of America's Public Policy Litigation & Law teams — are litigating in state courts to protect abortion access. Currently, bans are blocked in several of the cases where Planned Parenthood affiliates are plaintiffs, including Ohio, Iowa, and Utah.

We are also advocating for judicial reforms to restore people's trust in the courts and prevent our opposition from exploiting the judiciary by "judge shopping" for jurists that they think will agree with them — regardless of precedent. These reforms include expanding the Supreme Court, establishing term limits for Supreme Court justices, and overhauling the judicial ethics system.

We're working on multiple fronts to make abortion accessible and affordable for every person who needs care. However, with restrictions to care on the rise, it's crucial that everyone who cares about bodily autonomy steps up and helps us meet the resulting demand.

It's never been more urgent for you to put your beliefs into action and join us in connecting people to the care they need.
