Planned Parenthood will never be deterred from our mission to ensure that all people can access sexual and reproductive health care.

For more than 100 years Planned Parenthood health centers have delivered reproductive health care to millions of people sometimes under the most extreme circumstances.

Anti-abortion rights politicians exploited their power for decades to shift the balance of the Supreme Court to create an opportunity to end safe, legal abortion. Last June they achieved their goal, in *Dobbs v. Jackson Women's Health Organization*, when the 6-3 majority on the court ended the federal constitutional right to abortion, with devastating consequences.

Today over 20 million women of reproductive age, and more transgender and nonbinary people, have lost their right to abortion.

Few people actually believed that the hard-won right to abortion could be taken away. But the Planned Parenthood community took steps to prepare for a world without the protections of *Roe v. Wade*.

The enormous scale of this crisis means we need your utmost support now and in the months ahead.

You can help Planned Parenthood advance long-term strategies to connect people to care and ensure equal access to health care equity for all people.

The campaign to re-criminalize abortion and other reproductive care is shockingly cruel. People are being forced to carry pregnancies or struggling to manage miscarriages. Providers worry about being prosecuted and jailed. And the people hurt the most are those who already face obstacles to care due to systemic racism and discrimination.

Anti-abortion forces and their allied politicians are determined to dismantle reproductive rights any way they can. At least 18 states have already banned or severely restricted access to abortion, and more threats are on

the horizon. Medication abortion, in vitro fertilization, and some forms of birth control are all under attack.

No matter what happens in state houses or in the courts, Planned Parenthood is moving forward to advance reproductive freedom. We will never stop fighting to ensure that all people can get the health care they need.
